NOW, THEREFORE, in consideration of the participation by the undersigned in said mission trip(s) partly funded by Callie's Mission, INC, the undersigned does hereby release, discharge and save harmless Callie's Mission, INC, its directors, and/or board members from any liability, claims, demands or actions which may occur as a result of any injury, whether accidental or otherwise, illness or other loss which the undersign may sustain as a result, directly or indirectly, while participating in any of said mission trip(s) and activities, or participating in any and all types of activities, while in any country, or while traveling to and from said countries, to and from mission project sites, or any other traveling by the undersigned from departure from any airport in the United States of America until the time of return to any airport in the United States of America by any mode of transportation.

The undersigned further agrees that he/she will not institute any action or suit at law, or in equity, against Callie's Mission, INC, its directors, and/or board members at any time, and will not institute, prosecute or in any way aid in damages, cost, loss of services, expenses or compensation for or on account of any alleged damage, loss, injury, health problem, disease or illness to any person or property, or both, whether developed or undeveloped, resulting from or to result from, known, unknown, past, present or future by the undersigned's participation in mission trip(s) funded by Callie's Mission, INC.

The undersigned further acknowledges that he/she has been fully advised of the hazards, conditions and environment existing in said countries in which the mission trip(s) will be conducted and of various health and safe hazards which exist, and he/she fully understand and assumes all the risks involved in participation in said mission trip(s).

<sup>\*(</sup>Reference letters must come from the church of which the applicant is a member.)

<sup>\*\*(</sup>Remember that recommendations from family members will not be considered.)

<sup>\*\*\*</sup>DO NOT FORGET: When mailing application to make sure that it is postmarked (stamped) by the postal clerk with the postmark date of mailing.

<sup>\*\*\*</sup>INCLUDE proper postage. If the proper postage is not on the mailed application, your application will be rejected.

## Scholarship Guidelines Callie's Mission, INC. Updated May 18, 2018

- I. Scholarships will be awarded by the Board of Directors of Callie's Mission, Inc.
- II. All decisions of the Board of Directors regarding scholarships will be **final**.
- III. Scholarships will be awarded three times a year to the approved mission participants.
  - A. The deadlines for applications are <u>February 1</u>, <u>May 1</u>, and <u>November 1</u>.
  - B. First time applicants will have priority in regards to the awarding of scholarships.
- IV. The applications **must** be mailed. No application will be considered if it is date stamped after the deadline. The application envelope must include a postal date stamp. Improper postage will result in application rejection.
- V. All scholarship funds not expended on the mission trip sponsored by Callie's Mission must be returned to Callie's Mission.
- VI. Minimum eligibility requirements to be considered for a scholarship.
  - A. Applicant must be participating in an organized short term mission trip outside of the United States of America.
  - B. Applicant must be between the ages of **15 and 25** years old at the time of the mission trip.
  - C. Applicant must be a resident of the United States of America.
  - D. Applicant must be in high school, or
  - E. Applicant must be enrolled full time (minimum 12 semester hours) at a college, university, or seminary in an undergraduate program, or
  - F. Applicant must be enrolled full time (minimum 9 semester hours) at a college, university, or seminary in a graduate program.
  - G. Applicant must be a regularly attending member of a church.
- VII. Applicant must include a brief testimony of his/her salvation experience, and why the applicant feels God is calling him/her to the particular mission trip in which the applicant is participating.
- VIII. Applicant must provide a description of the mission trip in which he/she is participating.
- IX. Applicant must provide a description regarding how he/she came to know of Callie's Mission, and how he/she will help fulfill Callie's dream.

- X. Applicant must provide a payment schedule of when payments are due for his/her mission trip including plans for fundraising and any other organizations which have been petitioned for funds.
- XI. Applicant must include **four** letters of recommendation from his/her pastor (or other ministerial staff member), church member, mission team captain, and friend of the applicant.
  - A. All recommendation letters must be <u>hand signed</u> by the references.
  - B. The pastor and church member must be from the church of which the applicant is a member.
  - C. These recommendation letters must be mailed with the application. They cannot be mailed separately.
  - D. Recommendations from family members will **not** be considered.
- XII. Applicant must include his/her release form signed and notarized.
- XIII. Incomplete applications will **not** be considered.
- XIV. The committee may request a character reference from his/her pastor, church member, or friend.
